The Emergency Medical Services (EMS) Authority has opened a second 15 day public comment period for the draft regulations on the Appeal Proceedings to the Commission.

Pursuant to the requirements of Government Code section 11346.8 (c), and section 44 of Title 1 of the California Code of Regulations, the Emergency Medical Services Authority (EMSA) is providing notice of changes made to proposed regulation section 100450.100 which was the subject of a Notice of Proposed Rulemaking published in the California Regulatory Notice Register on March 13, 2015. These changes are in response to comments received regarding the proposed regulation.
