## Methedology

In CY 2017, EMSA collected some form of data from 30 (91%) of the 33 LEMSAs and 31 (94%) in CY 2018, Data presented in this report was collected in CEMSIS based on version 3.4 standards from NEMSIS.

The data in this report are extracted from CEMSIS, which is maintained by Inland Counties Emergency Medical Agency (ICEMA), the current EMSA data system contractor. The data is obtained from 30 LEMSAs that submit data from approximately 355 providers. LEMSAs submit data to this system on their own schedule, so that data may be submitted daily, annually, or on any other schedule in between. For this reason the report reflects data for CY 2017 and 2018 because submissions for this calendar year have largely stabilized and are most likely to have been completed by the mid CY 2019. The next report will be for the period of CY 2019.

The charts and graphs have been calculated by three different categories. EMS responses, 911 EMS responses, and 911 EMS transports. EMS responses were calculated by incident year (2017, 2018). 911 EMS responses was calculated by incident year (2017 and 2018), Type of Service Requested (911 Response (Scene) and BLS 911 Response (Scene) and 911 EMS transports were calculated using the same criteria as 911 EMS responses but with an additional criteria (Incident Patient Disposition (Patient Treated and Transported). These criteria are used throughout the charts and graphs unless otherwise stated.

#### **Limitations of Analysis**

This report uses descriptive statistics. The data and analysis are limited because after reviewing the data in CEMSIS, we have found discrepancies with some data elements and the values that have been chosen by the EMS providers but have not been mapped correctly within CEMSIS. Analysis is also limited as this report does not represent all of California; with Los Angeles County EMS Agency not reporting their data into CEMSIS.







### **EMS System Responses**

The total number of EMS calls submitted into CEMSIS was 2,734,919 in CY 2017 and 3,717,451 in CY 2018. This includes all calls including interfacility transfer, medical transport, mutual aid, and etc. 911 EMS Reponses represents 83% (2,734,919) in 2017 and 85% (3,717,451) in 2018. Out of these 911 EMS Responses, there were a total of 1,475,127 calls in CY 2017 and 2,082,802 calls in CY 2018 that had some form of patient contact.





Annual responses is defined as a 911 response in which a patient was treated and transported by an EMS unit.



Between January and December of CY 2017, 24 of 33 LEMSAs started submitting data into CEMSIS. Six LEMSAs started to submit data at a later date but we still received their past data hence the increase of records submitted during CY 2017. The six LEMSAs are Merced County EMS Agency, Santa Barbara County EMS Agency, San Diego County EMS Agency, San Mateo County EMS Agency, Solano County EMS Agency and Tuolumne County EMS Agency.






