Ms. Sabonis presented information on the definitions of misuse and excessive use of alcohol or substances of abuse from the National Institute on Alcohol Abuse and Alcoholism (NIAAA), the Center for Disease Control and Prevention, and the California

Health and Safety Code via PowerPoint slides in Attachment 1, slides 3 through 13.

Ms. Sabonis provided comparisons to the language of drug and alcohol violations used by the California Medical Board and the Board of Registered Nursing via PowerPoint slides in Attachment 1, slides 14 through 17.

Ms. Sabonis presented multiple case examples of the Administrative Law Judge's interpretations of misuse and excessive use of alcohol or substances of abuse via PowerPoint slides in Attachment 1, slides 18 through 35.

Ms. Sabonis discussed the history of the HSC 1798.200(c) violations via PowerPoint slides in Attachment 1, slides 37 and 38.

Ms. Sabonis presented the history of the AB 450 mandate, and discussed how the PDRB completed this mandate via PowerPoint slides in Attachment 1, slides 39 through 43.
